10th July update of COVID19 government guidance; Protective Measures for Out of School Settings during the Coronavirus outbreak

To reduce the risk of transmission within a setting, providers should aim to **IN SO FAR AS POSSIBLE** / use best judgement to

- minimise the number of different people each child comes into contact with.
- seek to maintain small, consistent groups of no more than 15 children and at least one staff member
- not mix groups within the setting

10th July update of COVID19 government guidance; Protective Measures for Out of School Settings during the Coronavirus outbreak

Government acknowledges challenges and advises the following

- Use your best judgement in creating and frequently reviewing groups to minimise mixing
- Keep up to date records
- Welfare and safeguarding a continued priority
- Sufficient time to clean and air rooms
- Prevent groups congregating at key times
- Outside as often as possible

Caring for mixed age groups

- From 20th July early years providers no longer deliver in bubbles
- Providers with both age ranges focus on minimising mixing
- Providers must apply the relevant guidance for the relevant aged children *could be offering care under two different guidance documents.

Questions raised on your behalf to DfE

1. There is some confusion out in the childcare market about September and if the guidance that was published on 2 July carries forward to the Autumn which it would seem to do based on the schools guidance that points to it regarding wraparound. However, will it be in September that before and after provision run by a third party can mix children in their bubbles of 15 or will then need to keep them in school centric bubbles?
2. We have a number of OSC provider that operate in one school/community premises but provide their services to other schools though collection of children in a walking bus type arrangement. They are concerned that the guidance omits this. Can the DfE provide some confirmation to the sector if these arrangements are possible providing they are able to meet the infection control measure
3. Do the holiday scheme providers need to keep children in the school bubbles from the end of term or can the bubble burst and the holiday playscheme open the new consistent bubble?

Opening in September

- No specific guidance yet
- School guidance for opening in September refers providers of out of school care and services to the 1st July Protective Measures for Out of School Childcare guidance and now 10th July update.
 - Discuss with school how best to proceed to ensure opening
 - Discuss with parents
 - Share risk assessment with other providers/parents & school





FISH Statistics

- We currently only have 182 of our Out of School Care providers in Hampshire on FISH out of approximately 500 providers.
- 975 Childminder records on FISH out of approximately 1,200
- FISH was accessed approximately 58,000 times in June 2020.
- Among these were 2,500 specific searches for childcare.

How is a service record created?

The service record should consist of two parts:

- Information from Capita – updated through the provider self-update portal [childcare service element]
- Information from FISH (through the portal) to add new or update [SEND Local Offer element]






